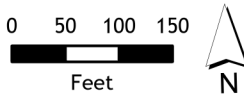
Grid Location Reference



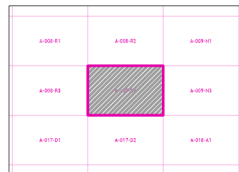

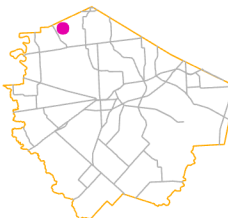
